President's remarks: Chuck Pugh

- 1. The AIUM meeting was held in NYC, in March, 1996. Two full sessions were devoted to veterinary ultrasound. The Veterinary and Animal Application Committee now consists of: Eric Wisner (chair), Karen Bauman. Thomas Hildebrandt, Brian Huber, Virginia Reef, Mark Saunders and Kathy Spalding.
- 2. Allocation of the money which has been accumulated from dues collection was brought up. Dr. Pugh suggested that some be used to support residents' projects. In addition, he suggested that the VUS support a keynote speaker at the next ACVR meeting in December, 1997. No objections were raised to this proposal.

New President's remarks: H. Mark Saunders

- 1. The next AIUM meeting will be held March 23 26, 1997 in San Diego; west coast radiologists were encouraged to submit abstracts. Last year in New York City, the zoorelated topics were the best attended. Abstracts for this years meeting have been reviewed; one session has been filled with veterinary topics.
- 2. The question of the role that ultrasonographers who are not veterinarians should play in veterinary ultrasound was raised and discussed. Several veterinary schools have been approached by sonographers wanting veterinary training. U. Penn has not accepted any; Tufts has. Ron Sande at Washington State would encourage the training of technicians in veterinary ultrasound to give the radiologist time to do other things. State practice acts restrict the practice of veterinary medicine to licensed veterinarians, which would seem to prohibit a sonographer from going into the business of performing ultrasounds on his/her own, but this appears to be a gray area. These people would legally be required to have their examinations reviewed and diagnoses by a veterinarian. Obviously, veterinary radiologists do not have exclusive rights to do ultrasonography on animals. Part of our role should be to do what we can to educate practitioners in the use and interpretation of ultrasound. To this end, Chuck Pugh suggested that the proposed imaging protocols be finalized and adopted soon.

"Ultratalk" - in **Veterinary Radiology & Ultrasound** and on the internet: Chuck Farrow

1. The Ultratalk website seems to be a virtual secret among veterinary radiologists. Most of the more than 2000 hits seem to have come from private practitioners. To make the site more useful, Chuck Farrow would like to publish more abstracts of meetings which are attended by individual members of the college. He also proposed a forum on the various available machines, with members sharing their experiences. (This would also prove helpful to practitioners who were considering a purchase.) VUS Business Meeting Minutes - December 4, 1997

- 1. Previous meeting held December 7, 1996. Minutes were published in Veterinary Radiology & Ultrasound (Vol 38, No. 3, May/June 1997))
- 2. Old Business:
- a. Keynote Speaker

The keynote speaker in the ultrasound session for the 1997 ACVR/Veterinary Cancer Society meeting was Dr. Larry Needleman, Assoc. Professor of Radiology from Thomas Jefferson University and Jefferson Medical College, Division of Diagnostic Ultrasound and The Jefferson Ultrasound Research and Education Institute. He spoke on "Advances in Ultrasound Imaging of Cancer". His honorarium was paid for by the ACVR and VUS.

b. Accreditation of Veterinarians and other professional performing ultrasound examinations:

The Executive Council of the ACVR has discussed the issue of ultrasound accreditation. Dr. John Hathcock, ACVR President, wrote in a letter to VUS President, Dr. Mark Saunders, that the ACVR had previously adopted the following policy: "It is the position of the ACVR that sonograms can be performed on animals by qualified technicians, sonographers, or veterinarians, but that the interpretation of veterinary sonograms is the practice of veterinary medicine and should only be performed by a qualified veterinarian". The ACVR Executive Council believes that "regulation of

veterinarian practice is the role of individual state boards and not the ACVR." From the 1995 ACVR Executive Council minutes Dr. Hathcock found that the "Council feels that accreditation or certification of sonographers is beyond the jurisdiction of the ACVR and request that the VUS as an ACVR-sponsored society not pursue accreditation or certification.

c. VUS sponsored funding of computed-aided learning programs and research projects:

At the December 1996 meeting, Bill Blevins brought up the issue of the VUS - sponsored funding of ultrasound computer-aided learning programs and research projects. We made the offer to the ACVR that the VUS sponsor funding of the ACVR Resident Research Award if the project pertains to ultrasound.

Dr. Saunders was called before the meeting by Dr. Sue Kraft, organizer of the computer-aided program demonstration at the 1997 meeting. She inquired whether the VUS would be willing to help defray the cost of computer rental. Monies were eventually found elsewhere, but Dr. Saunders felt that VTJS funds would be better spent funding ultrasound-related ACVR Resident Research Award and ultrasound-related teaching programs.

3. Treasure Report

Dr. Dan Feeney reports there is \$14,600 in the VUS account.

4. 1998 ACVR meeting in Banff, Alberta

John Pharr, meeting organizer discussed the tentative schedule and social attraction of the scientific meeting.

5. New Business:

a. "UltraTalk" - the official VTJS publication:

A discussion at the ACVR Executive Council meeting in December 1996 concerning "UltraTalk" occurred and Dr. John Hathcock communicated Council's comments to Dr. Saunders in writing. Council was concern that "this newsletter as published in the Journal (Veterinary Radiology & Ultrasound) may not be meeting the needs of the Veterinary Ultrasound Society in that it is becoming more of a forum for a few people rather than the Society at large" and the VUS "may wish to consider whether the newsletter is meeting the goals and objectives of the Society in its present form". Dr. Saunders responded to Council's comments. The current situation has occurred because the editor, Chuck Farrow, has been sorely responsible for the newsletter. The fact that the VTJS even has a newsletter is due to Dr. Farrows efforts. Despite Dr. Farrow's repeated efforts, no one else has contributed to "UltraTalk". The newsletter has temporarily ceased publication in the Journal and the VUS web site had not been updated.

Other contributors are encouraged to submit items for the web page and "UltraTalk". Potential items for submission: list of new ultrasound products, reviews of ultrasound textbooks, list of ultrasound continuing education meetings, etc.

b. Proposed VUS Executive Committee

The VUS Constitution, drafted in 1990, outlined the formation of an Executive Committee as such:

Past president (one year)
President (one year)
President-elect (one year)
Corresponding Secretary (two-years)

Historian (two-years)

In 1993, the president's term was permanently lengthened from to two years when Dr. Virginia Reef was elected for a second year. Unfortunately, the structure and function of the Committee structure has eroded with disuse. During the year, the president must address any and all issues facing the VUS. Decisions must await the annual meeting and there is little continuity between presidential terms. Continuity, the need to act upon decisions reached at annual meeting and deal with issues between annual meetings are reasons to resurrect the Executive Committee.

Minutes of the Annual Meeting of the Veterinary Ultrasound Society December 2, **1999**, Chicago, IL.

The meeting was called to order at 7:05am CST by the current president, Bob O'Brien, who reported that there was \$16,400 in the VUS account before the present meeting. Some of that went to help pay for the speakers in the Special Session on Advanced Ultrasound Physics. A co-sponsor (didn't catch the name) also contributed.

There are currently no plans for an ultrasound special session at next year's meeting, which led to a discussion of various options. Given the concern on Council that the meeting is getting larger but can't get longer, the solution may include split sessions or not covering every modality in special session every year. Members' comments emphasized the fact that US and Dx Rad are basic modalities and should be covered every year in a way that targets veterinary radiologists specifically. The membership, by a show of hands, proved to be overwhelmingly in favor of an annual invited speaker in ultrasound so Dr. O'Brien called for suggestions of topics. He also suggested the possibility of combining a speaker with a happy hour, as is done at the RSNA, an event for which we might again seek co-sponsorship from among our affiliated vendors.

Finally, Dr. O'Brien suggested that anyone not already on the VUS list-serve make sure that she/he is on it, and thanked Mike Bernstein for including the non-ACVR VUS members in the meeting at no charge. (not sure if they were allowed to come to the whole thing or only to the VUS-related parts)

Dr. Tom Nyland next took the floor to talk about the VUS part of the ACVR Webpage. Given the paucity of contributions, there is still plenty of space available for images. He envisions it as a forum for discussion and a place where images associated with meeting abstracts might be displayed. Links are in place to various partners (e.g. Aloka), giving access to — among other things — their schedules of CE courses. Dr. Nyland said that the abstracts of the keynote talks would be posted/sent out to members. Mention of abstracts led to a short discussion of the inadequacies of many of the printed abstracts in the proceedings book and how that could be remedied, possibly by posting up-dated versions on the website. Someone asked if it would be possible to record the entire meeting on videotape and make it available on the web to supplement abstracts, but that was considered an unwieldy alternative to up-dated abstracts. (The above discussion extended to mentioning the need to provide future ACVR speakers with up-dated A-V equipment so that computer slides and short films could be used in presentations.)

A brief discussion of the listings of CE courses in ultrasound was led by Dr. Mark Saunders. Some information is listed on the VUS site on the "meetings" page, and more is available through links to vendors' homepages. Dr. Saunders volunteered to collate the available information in one place.

Dr. O'Brien retook the floor to talk about combined sessions with the ACVIM which are still in the works for 2000 or 2001. The incentive is to publicize our group and expand membership. The commitment is for 1-3 years and it might be a reasonable way to spend some of our accumulated treasury money.

Elections followed. Lisa Neuwirth was elected President-elect and (I totally missed the other election because I was counting the ballots for president-elect!!!)

A short discussion of VUS-sponsored ultrasound courses around the country followed the election. Many members are doing them, not so much for the money but to promote the group and to be proactive in quality control. The feeling was that we should be setting standards more than acting as police.

The new president, Dr. Ron Sande, said a few words as the hour came to an end. He promised to be more active and encouraged everyone in the group to do the same. He also wants to develop a registry for non-veterinarian veterinary sonographers (technologists) and promote their acceptance in veterinary radiology.

The meeting was adjourned at 8am.

The Veterinary Ultrasound Society Annual Meeting was called to order by Bob O'Brien, past-president, at 7:00 AM. Current president, Ron Sande and president-elect Lisa Neuwirth were unable to attend.

A motion was raised for approval of the old minutes of the 1999 Annual Meeting (distributed by e-mail), seconded and unanimously approved.

Old Business:

CE Calender:

Mark Saunders reported on progress of the Continuing Education Calendar on the ACVR/VUS web page (http://www.acvr.ucdavis.edulsocietivus/ce). The calendar is updated month with listings from the JAVMA calendar and notices sent to Dr. Saunders by people or companies offering ultrasound CE seminars. Tom Nyland, ACVR web master, places the updated calendar on the web site. The ACVR Executive Council has previously decided that only programs offered by ACVR Corporate Sponsors (e.g., Sound Technologies, Universal Seminars), academic institutions and ACVR diplomates should be included. If seminars are being offered, please e-mail the information to Mark Saunders.

Dr. Saunders also reminded VUS members to use the list serve as means of communicating important information, seminars, interesting case images or questions. All VUS members benefit from this mode of communication.

ACVIM Forum.

Bob O'Brien reported on the status of the VUS association with the American College of Veterinary Internal Medicine. For the past several years, the VUS has been seeking to have a block of ultrasound-related talks given by the VUS members at the AC VIM

Annual Forum. Dr. O'Brien was successful this past year in having the VUS obtain allied status with a 2-year probation period. The VUS has been granted a four-hour block at the 2001 ACVIM Forum in Denver; four forty-five minute talks on pancreatic imaging will be given by Drs. Penninck and Saunders and moderated by Dr. O'Brien. Dr. O'Brien is also in the process of arranging an US imaging wet lab offered through the ACVIM Forum and sponsored by Sound Technologies. This half-day lab will probably be held at a local private practice in Denver. Speakers and wet lab instructors will be paid a speaker honorarium. A discussion ensued concerning what the VUS receives in return. The VUS and the ACVR will receive exposure with the internal medicine group; in the future the VUS is trying for reduced ACVIM registration fee for VUS members and possibly a reciprocal one day forum with the ACVR Scientific Meeting given by ACVIM diplomates.

2001 ACVR Meeting:

Dr. O'Brien discussed the future plans for the 2001 ACVR Scientific Meeting in Hawaii next August. Dr. O'Brien will also be the ACVR Program Chair for the meeting. The question was raised whether the VUS should have a sponsored speaker for the US portion of this the meeting. It will be expensive to support bringing a speaker from the mainland. Options discussed were: 1.) support the ACVR general keynote speaker if the topic is on some aspect of ultrasound, 2.) search for local (Hawaii) US keynote speaker, or 3.) have Drs. Pennink and Saunders present their ACVIM Forum talks. Dr. Partington raised the question whether the VUS should sponsor a US Forum gear for practitioners (similar to ones given in Chicago and Banff) or a scientific forum geared towards VUS members which interested practitioners could also attend. Others strongly felt that we should arrange a scientific program that benefits VUS members rather than private practitioners. Dr. O'Brien concluded the discussion by requesting the names of potential local (Hawaii) keynote speakers or topics for a US Forum.

SDMS Veterinary Task Force:

Dr. O'Brien had in hand a letter from Tomie Timon, Chair of the Society of Diagnostic Medical Sonography (SDMS) Veterinary Task Force (members: Jan Bryant, Fern Delaney, Laura Hansen). Tomie Timon is an applications specialist for Sound Technologies. The SDMS Veterinary Task Force was formed to develop a line of communication between the SDMS and the veterinary imaging profession through the VUS. The ensuing discussion was positive for developing communication between the VUS and SDMS because we must be seen as pro-active and RDMS involvement in veterinary US imaging will take place with or without the VUS. Issues raised were numbers of SDMS members involved, do they want to start certification, do they want the VUS to help with wet labs, could they reciprocate by presenting wet labs for the VUS (e.g., vascular imaging)? Dr. Partington recommended formation of a subcommittee to work with the SDMS. The motion to form a subcommittee was raised, seconded, and approved. Volunteers were requested to serve on this committee.

Elections:

Dr. O'Brien called for nominations for president-elect. Dr. Martha Moon agreed to have her name placed on the ballot. As the only nominee, she was unanimously approved as

president-elect. At-Large Council had one vacancy (created by Dr. Chuck Root's term expiration; Dr. Kathy Spaulding has one year remaining). Dr. Jeffrey Siems had previously agreed to have his name placed on the ballot and as the only nominee, was approved unanimously. A suggestion was made to seek future nominees for elected positions from outside the ACVR.

VUS Constitution:

During the election for At-Large Council members, the question was raised concerning the term length for the At-Large Council positions. When the At-Large Council was initially created in 1997 members were Chuck Root (2-year term) and Kathy Spaulding (3-year term); the Council added to the core group of VUS elective officials (past president, president, president-elect, treasurer, secretary). The decision for the initial 2-year and 3-year terms for the At-Large Council members was based on providing some short-term stability. No official length of term has since been decided. This deficiency raised the issue of the VUS Constitution revision. The original VUS Constitution was developed in 1989-1990 when the VUS was formed (Dr. Spaulding, president), but has been largely ignored. There was a motion to form a subcommittee to revise the constitution; the motion was seconded and approved. Dr. Spaulding agreed to serve as chair of the VUS Constitution Revision subcommittee with Dr. Nyland agreeing to advise the process (using his experience from the ACVR Constitution Committee). Volunteers from the membership were requested. An e-mail request for volunteers (for both the VUS-SDMS and Constitution Committees) using the list serve was recommended.

NEW BUSINESS:

No new business was brought forth.

The meeting was adjourned at 7:50 AM.

Addendum:

Treasurer's Report was not given at the meeting. There currently is a balance of \$15,940.95 in the VUS account. Ultrasound keynote speakers honorariums and travel expenses have yet to be deducted.

The meeting was called to order at 7:30am by Lisa Neuwirth, president. An attendance sheet was passed around (but may not have reached all those in attendance); those who signed are listed at the end of these minutes.

Old Business

Bob O'Brien reported on the wet lab put on at the AC VIM by several VUS members, including J. Stefanacci, Jen Laury (? I can't find this name in the membership list so perhaps it's wrong), and Mark Saunders. (There were others I didn't get.) This is an ongoing effort by the VUS to raise our visibility. This coming year a block of 4 hours is scheduled. Anyone interested in presenting on small parts or vascular ultrasound should get in touch with Bob O'Brien.

The subject of what sort of relationship we should have with the Society of Diagnostic Sonographers recurred. Members of that society have formed a task force to investigate the possibility of joint educational programs with us and more standardized scanning protocols in animals. They are also looking at a separate certification within their society for veterinary imaging. It may be possible/desirable that we participate in the formulation of the exam criteria for such a certification. Lisa Neuwirth will be sending members of the VUS a questionnaire on the subject to get a better sense of what we think as a group.

We have accumulated approximately \$17,000 in the VUS treasury, prompting the ACVR to urge us to spend some of it on members. Some discussion of how we could use it followed. Mark Saunders remarked that members don't really receive much for their dues. Tom Nyland suggested holding ultrasound courses for VUS members only during the ACVR meeting. Linda Konde thought a round-table discussion on an US topic during the AC\TR meeting would be useful.

New Business

Bob O'Brien presented a proposal for a new ultrasound group to be called the International Veterinary Ultrasound Society. He handed out a sheet detailing his reasoning on why the meeting was needed and what the goals for the meeting would be. No mention was made of how the IVUS had been formed, nor were any other details about its structure given. Two venues for a meeting in the summer of 2002 had been researched and were presented for consideration. Some discussion ensued and then Bob asked for a vote on the general concept. By a show of hands, 14 ayes and 8 nays were recorded. A second vote on the proposed venues followed: Lake Tahoe —9, Salt Lake City-6.

Lisa Neuwirth reported that a committee had been formed to review the VUS constitution and change it where necessary. She hopes that a meeting of this committee will happen in the upcoming year.

Elections followed. Dan Feeney was retained as treasurer by acclamation. Sue Finn-Bodner was elected to Council and joins Jeff Sims in that position. Kathy Gelatt-Nicholson was elected secretary. Jay Stefanacci was elected to follow Martha Moon into the position of president.

After the election, Mark Saunders reminded members that there is a calendar of CE opportunities on the ACYR Website. Courses are limited to those given by VUS/ACVR members or our corporate sponsors. The list is maintained by Mark through webmaster Tom Nyland. Mark urged members to make use of this resource.

Finally, Bill Blevins brought up the subject of US terminology and the lack of agreement thereon among ultrasonographers. Standard protocols were attempted early on for abdominal studies but no clear agreement was reached. This situation contrasts with the uniformity achieved by those doing cardiac examinations. The difficulty seems to arise, at least in part, because of the varying position of some organs, depending on what position the patient is in during the exam. Some discussion followed but no agreement was reached.

Lisa Neuwirth adjourned the meeting at 8:20 am.

VUS MEETING MINUTES

December **2002** Chicago, IL

1. Treasury report (given by Marti Moon, VUS President on that day): \$17,000 current amount available in all VUS fund holdings. Again, the questions were raised as to why we haven't spent any of this and what we can use of this amount for in the future (discussion began in this regard.....)

OLD BUSINESS

- a. IVUSS will hold its second annual meeting this August 27-30 at the Chico Hot Springs Resort in Pray, Montana. Historically, indoctrination of this society, conceived (in 2001) and spearheaded by Dr. Robert O'Brien, occurred at its first meeting in August 2002. 40 Attendees from the United States and various European and Asian countries registered for this meeting and participated in keynote presentations, special topic sessions and wet labs. Six health-care providers sponsored this event. Discussion ensued about the acceptance by the VUS of the IVUSS and our society's willingness to allow society funds to be used for their purposes. Drs. Tom Nyland and Mark Saunders reiterated the ACVR Council's decision to reject this proposal in the past, citing potentially damaging competition by exhibitors for each event and inadequate time to plan IVUSS events separate from the ACVR annual meeting.
- 1. VUS members agreed to and voted to use SOCIETY funds to help support a conjoined meeting with VUS/IVUSS every 3 years at the resort meeting.

b. ACVIM meeting

- 1. Forum 2003 and update was discussed
 - a. History of our Affiliation was mentioned, which included passing ACVIM probation and success of the previous two VUS sponsored imaging wet labs and lectures held in Denver and Dallas.
 - b. 2003 meeting will be held in Charlotte, NC, June 4-8.

Certified medical sonographers

- 1. Discussion revolved around forming a committee to evaluate whether VUS Shirt be more involved in AIUM.
- 2. Drs. Marti Moon, Bob Toal and George Henry agreed to be on that committee.
- d. VUS constitution revison was discussed. The original document was written in 1990 and no one can remember it! Drs. Saunders, Nyland and Stefanacci agreed to be on that committee.

3. **NEW BUSINESS**

- a. Elections took place.
 - 1. Dr. Marti Moon: immediate past President
 - 2. Dr. Jay Stefanacci: President
 - 3. Dr. Kristina Miles: President-Elect
 - 4. Dr. Kathy Gelatt: Secretary
- b. Council Member-at-large selection
 - 1. Dr. Saunders indicated that these positions are vital to pass ideas from VUS to ACVR council.
 - 2. Dr. Sue Finn-Bodner holds one position for another year.
 - 3. Dr. Dominique Penninck volunteered to take the second posiiton for the next 2 years (2003, 2004).
- c. Use of VUS funds for IVUS meetings
 - 1. Discussion ensued from doctors Saunders, Henry, Blevins and Nyland regarding this complicated issue.
 - 2. The VUS voted against use of VUS funds for IVUSS functions held separately, but voted in favor of using these funds for meetings held in conjunction with ACVR, i.e. resort meetings. The 2004 resort meeting will be held in Montreal and a plan to institute this idea will be developed for that meeting.
- d. VUS funding of research grants
 - 1. Discussion ensued regarding using VUS funds to completely or partially support a resident research grant every other year.
- Dr. Dominique Penninck volunteered to submit a proposal for the VUS to the Resident Research Committee of the ACVR Council for this purpose.

Veterinary Ultrasound Society (VUS) Meeting Minutes Saturday, December 6, 2003 O'Hare Marriott, Chicago, IL

- 1. VUS meeting minutes from 2002 distributed and current meeting called to order by Dr. J. Stefanacci.
- 2. Motion to approve meeting minutes from 2002 made and seconded. Approved with voice vote. No 2003 treasury report available. VUS funds reported at \$17,000 in the 2002 meeting minutes. Current number of VUS members was not available at this time.

Old business:

- a. How to use VUS funds?
- Decision made at 2002 meeting when to use some VUS funds to sponsor speakers in conjunction with ACVR at "resort" meetings. For example, VUS and IVUSS will present a block of topics at the 2004 ACVR meeting in Montreal.
- The VUS blocks will likely be held at the same time as the MR/CT society blocks, but scheduling has not been finalized by ACVR.
- The 2006 ACVR resort meeting in Vancouver may be our next opportunity.

b. VUS Research Grants for residents

- ACVR council likes this idea, but still needs a formally worded proposal.
- VUS would provide funds (up to \$5,000, possibly every other year, or as monies are available) to the ACVR committee on resident research grants, with a VUS member included on this committee to review proposals.
- Dr. Dominique Penninck had volunteered to organize this project at the 2002 meeting.
- Dr. Penninck will need to submit a formal proposal to the ACVR Council by the April 2004 meeting.
- The proposal should include a submission procedure for the grants.
- However, an application is already in place for ACVR sponsored resident research grants, so this form can be used or altered if needed.
- Residents from any discipline are eligible to apply for VUS and ACVR resident grants as long as Animal Care Committee approval has been obtained at the home institution.
- Dr. Anne Bahr is the current chair of the ACVR committee on resident research grants.
- Dr. Greg Daniels commented, as former chair of this committee, observing ultrasound-based resident research proposals in approximately 25 % of submissions.

c. Recording of VUS sponsored presentations

- Dr. Marti Moon initiated discussion on use of VUS funds to videotape or otherwise record VUS sponsored presentations at the 2004 ACVR meeting in Montreal.
- The CT/MR society has also suggested recording presentations on either videotape (estimated cost \$1,500-3,000) or slide show with audio voice-over recorded on a CD (estimated cost \$1,300).

- Professional videotaping may be provided less expensively by the Marriott in Montreal or by relatives of Dr. Connie DeHaan.
- No final decision was reached concerning which organization would control any tapes or CD produced.
- VUS would likely need some type of written permission from speakers.
- Discussion remained open concerning cost of recordings to VUS and non-VUS members.
- Dr. Nyland proposed obtained agreement of ACVR Council to proceed with videotaping. Motion seconded by Dr. George Henry. Approved by voice vote.
- Dr. John Mattoon volunteered to head ad hoc committee to organize this project along with Dr. Lori Hartzband.

d. VUS role with ACVIM

- VUS has successfully completed the probationary period set by the ACVIM Forum, in part due to outstanding participant reviews.
- VUS will be providing a variety of speakers at the 2004 ACVIM Forum in Minneapolis, including:
 - 4 hours of lecture on hepatic imaging topics
 - 12 hours of film reading sessions
 - 4 hours of cardiac ultrasound wet labs
 - 6-8 hours of small parts ultrasound wet labs
- Dr. Stefanacci encouraged VUS member participation at the ACVIM Forums, which will be in Baltimore in 2005 and New Orleans in 2006.

e. VUS Policy on medical sonographers

- Dr. George Henry reports strong interest for increased interaction with VUS members from medical sonographers at a recent Dallas meeting.
- However, Dr. Henry expressed concern about responsibilities of image interpretation.
- Various VUS members reiterated that medical sonographers cannot legally practice veterinary medicine.
- One suggestion was made: to encourage the practice of ACVR Diplomates providing ultrasound image interpretation for medical sonographers performing sonographic evaluations on animal patients.
- None of the VUS members in private practice who were present at the meeting are currently engaged in business with a medical sonographer.
- Drs. Marti Moon, George Henry, Bob Toal and Debra Beard agreed to continue work on a committee to look further into this issue and provide suggestions for a VUS policy statement.

f. VUS Constitution

- No progress was reported on review and revision of the VUS constitution.
- Dr. Tom Nyland suggested that a Standard Operating Procedures (SOP) format would be most succinct and user friendly.

- Dr. Nyland further suggested that the VUS Constitution and meeting minutes should be posted on the ACVR web site.
- Dr. Marti Moon will mail copies of the current VUS constitution to Dr. Nyland, Dr. Mattoon and Dr. Miles.

4. New Business:

- a. Montreal August 2004
- Dr. Bob O'Brien is organizing the VUS components of this meeting, along with Dr. Stefanacci.
- VUS has arranged for two keynote presentations, and will pay fees for these didactic speakers. No fees for didactic speakers will be requested from IVUSS.
- All IVUSS members will pay full ACVR registration fees.
- VUS and IVUSS will also arrange instruction for a day of wet labs.
- IVUSS might help provide funds for videotaping sessions.

b. Interstate Consulting

- Dr. Stefanacci asked if any VUS members could provide an update on interstate consulting issues.
- Dr. Bill Blevins commented that a federal bill providing protection for the consultant was being considered at one time, but the outcome of the bill's progression was unknown. Senator Ted Kennedy was a sponser of the bill.
- Dr. Ron Green added information on an Idaho law with possible negative wording that was later clarified in a legal process with wording more favorable to the consultant.
- Dr. Mattoon indicated that the ACVR Council has looked into this Idaho ruling.
- VUS members informally agreed that radiology consultations were not significantly different from Cardiopet or other world wide consulting services.
- AVMA is not currently pursuing this issue as a current topic, although it has been visited in the past.

c. Elections

Minutes-Veterinary Ultrasound Society (VUS) Annual Meeting August 2004

- 1) Past Minutes were previously posted on the web for review. Dr. Miles asked for a motion to approve the 2003 meeting minutes. So moved, seconded and the minutes were approved.
- 2) Dr. Miles reported all past meeting minutes since 1989 and the original VUS constitution are now available on the ACVR website courtesy of Dr. Nyland. Thanks to Dr. Nyland for his efforts. Drs. Stephanacci and O'brien were also thanked for their hard work in organizing and running VUS sponsored CE programs this week as well as for past work. They are planning for a future GI US and radiology CE program at the 2005 ACVIM Forum in Baltimore.
- 3) Dr. Rob McLear (Treasurer) reports 188 VUS members paying \$25/year dues (\$15 of this goes to the ACVR). \$22,600 was in the treasury as of 6/04. Approximately \$4000 of this was paid to speakers for work at this week's ACVR meeting. Yearly income from dues is approx. \$2000. It was discussed that this is not enough alone to fund a yearly \$5000 US grant for residents.
- 4) VUS SOP (standard operating procedure) proposed new SOP has been posted at the VUS site on the ACVR site for the past two months and is pending approval. Dr. Miles proposed removing sections 2.2 to 2.7 and to replace (retire) the original VUS bylaws and run VUS society based on the current SOP to simplify operation of the VUS society. A motion was made to this effect, seconded and approved by membership. The revised SOP to be posted on the VUS portion of the ACVR web site for an electronic vote of approval or rejection by VUS members not present at today (on-line voting to be set up by Dr. Nyland.)
- 5) Dr. Miles asked for discussion concerning length of tenure for members at large, president and president elect positions. Should they be 1, 2 or 3 year durations to facilitate continuity. Currently these positions are staggered and would not be replaced during any same year to facilitate continuity of society information and goals. Dr. Saunders commented that the council at large member aids the president as a driving force in running the VUS. Debate over duration of member at large position ensued. Most members expressed support for a 2 year term. A motion was made and approved that the member at large position be 2 years.
- 6) A motion was made by Dr. Saunders and seconded by Dr. Goggin, for the president and president elect to be 2 years and cycle every December 1 to parallel the ACVR presidency. The motion was approved by majority vote.
- 7) A motion was made to alter the VUP SOP section 5.3 regarding the quorum. Previously 20% of members necessary. A majority of members present at each meeting was proposed as necessary for voting and approval of VUS motions. This will be included in the revised VUS SOP. Dr. Nyland commented that issues

- planned for vote could be posted on the web and emails or letters sent to members to alert them and allow comments to be generated. Voting on line is also possible per Dr. Nyland.
- 8) Unfinished business VUS sponsored resident research grant. Comment that if we sponsor a VUS society grant every other year our bank account will be drained in 5-10 years. Others commented that if we don't utilize the current funds they benefit no one, and if we run out of funds in the future we can alter our granting policy at that time. VUS granting frequency was discussed. January 31st was proposed as the date. Comments also made that \$5000 grants may not be large enough, and we may be better off contributing to the ACVR funded resident grants.
- 9) A motion was made to provide (if a suitable grant is submitted) a VUS funded grant every other year of \$5000. Deadline July 1st starting this year July 1st 2005. Applicants for the VUS grant will apply by completing the ACVR grant application submitting it to the ACVR grant committee and the ACVR grant committee will determine if there is a suitable recipient applying to fund an US related research project. An ACVR diplomate must be a co-investigator. Project results to be presented at ACVR annual meeting. If no suitable candidate applies, the funds will be made available the next year and then return to an alternate year funding cycle. VUS will strive to have the VUS president elect or other member serve on the grant committee. Approved by membership.
- 10) Dr. Mattoon nominated Dr. John Shiroma for president elect. Dr. Nyland seconded. Members approved.
- 11) Meeting adjourned.

- VI. New Business Discussions of performance of sonograms by non-radiologists and non-veterinarian sonographers.
 - A. <u>ACVIM training requirements</u> Members of the college have been informally informed from colleges in the ACVIM that this specialty college is planning to revise their resident's training requirements to include some formal training in diagnostic ultrasound imaging. Dr. Mattoon asked the VUS members opinions regarding if the VUS should be proactive in assisting or advising ACVIM leadership in providing this training or training guidelines, or be passive. The following items were mentioned in a discussion:

The importance of approaching the ACVIM in a partnership (versus a mandate) was presented. (Bill Hornof) It was also noted that other specialty colleges, for example ACVS have requirements that surgical residents spend a certain number of hours working with an ACVR diplomate as part of their training. These requirements were previously set up independent of the ACVR (Bill Blevins). Similar requirements instituted by other specialty colleges may impact individual ACVR diplomates at academic institutions. It may be valuable to open a dialog with the ACVIM regarding training requirements before they make unilateral decisions that may impact ACVR diplomates.

It was proposed and agreed that a dialog should be initiated with the ACVIM and Dr. Mattoon will extend formal contact to this organization as a representative of the VUS and ACVR, to determine if the ACVR can assist their college with this process.

B. New Business- <u>Discussion of performance of US exams in veterinary patients by technicians/non-veterinarians.</u> The following items were mentioned in a discussion regarding this topic and with regard to performance of US exams by non-radiologists:

The VUS formed a committee at the 2005 meeting to develop a position statement regarding ultrasound technologists performing examinations.

Shortage of radiologists due to reduced funding of veterinary universities and trend for new radiologists to go into private practice. Importance of setting up residency programs in private practice to increase numbers of competent ACVR diplomates.

The role of RDMS to obtain images, but not make diagnosis or perform interventional procedures such as aspirates (Jeff Seims)

In the human medical field diagnostic medical sonographers are supervised directly by specialists and relationships typically exist where the specialist can "step in" to complete a given US exam when the sonographer or specialist feels it is indicated. The role of sonographers is to extend the reach and productivity of specialists (Bill Hornof).

Individual state practice acts already limit independent non-veterinarian sonographers from performing ultrasound on veterinary patients (Joan Regan) without direct oversight by a licensed veterinarian.

Education of the public on the expertise of ACVR diplomates to distinguish us from the independent sonographers

Importance of investigating the current training and licensing already in place for diagnostic medical sonographers practicing in the human medical field to learn from the experience in the human medical field. Formation of a review committee was mentioned. Initial step should be fact finding (AIUM, SDMS, etc.) (Tom Nyland)

A motion was approved to have this committee also investigate whether current training requirements and programs for human medical sonographers (RDMS) can be modified for veterinary use. Dr. Bob Badertscher volunteered and was approved by membership to head this committee. VUS members who volunteered to assist Dr. Badertscher include Dr. Beard, Dr. Stefanacci and Dr.Larson.

Veterinary Ultrasound Society Annual Business Meeting Wednesday November 28, 2007

Meeting called to order 7:05 am by President Jon Shiroma

Minutes from the 2006 Business Meeting (Vancouver, BC) were unanimously approved.

The Treasurer's Report was unavailable but Dr. Shiroma relayed to the membership that the VUS is in good financial position according to ACVR Treasurer Robert McLear. A detailed report will be available in the near future.

The VUS will sponsor a Resident Research Grant of \$5000 in 2008. Dr. Shiroma has sent an email to alerting ACVR members.

Dr. Shiroma reported that Dr. Bill Hornof (ACVR President) met with constituents of the ACVIM in Seattle in June 2007. Discussion indicates that the ACVIM may require 40 hours of dedicated ultrasound training as part of their residency requirements, which will be converting to a 3-year program. This has not been finalized, nor have any details been forthcoming.

A recap of the VUS Steering Committee was provided by Dr. Shiroma. In short, the Committee has stalled. Dr. Badertscher (Chair) spoke, summarizing the complexity of the task. Brief discussion ensued regarding the results of the current ACVR membership survey as pertains to ultrasound and how this will likely effect further steering committee direction, as there was overwhelming non-support of ACVR acting as an ultrasound credentialing body for non–ACVR DVMs, technologists and technicians.

Discussion then focused on the VUS forming standards/guidelines/recommendations that may be followed by others interested or with vested interest in ultrasound training/credentialing (e.g., ultrasound companies, veterinary technician programs, other forms of CE, etc.). VUS members in attendance seemed to be in agreement.

Council members in attendance felt that this type of approach would be supported by ACVR membership if proper proposals can be generated.

Drs. Hornof and Mattoon met with ACR Board of Chancellors Chair Dr. Arl Van Moore and Vice Chair Dr. Jim Thrall on Sunday, November 25th at the RSNA meeting to establish an introductory relationship between organizations. Brief discussion on the roles of the American College of Radiology was presented. It will be prudent to identify common threads between their organization and the ACVR and utilize their knowledge and expertise as the ACVR (and VUS) move forward. The ACR is willing and seemingly eager to help the ACVR in any way possible.

It was noted that similar guidelines should be constructed for all of the imaging disciplines within the ACVR. This in turn led to a brief discussion on the current ACVR

Mission Statement (to educate and credential competency in imaging) and how our mission statement must be carefully considered and revised to reflect emerging areas of importance (marketing, standards, etc.). This will be a topic of discussion at the 2007 General Business Meeting.

Nominations for president elect, 2 at-large members and secretary will be voted at the next ACVR meeting in San Antonio.

IV. New Business – Results of the ACVR Ultrasound Steering committee

Last year, an ultrasound steering committee comprised of John Mattoon, Seth Wallack, Bill Hornof, and Jon Shiroma was organized. The final outcome of the steering committee was the following statement.

ACVR Position Statement on Veterinary Ultrasound Diagnostic ultrasound is considered the imaging modality of choice for many conditions in veterinary medicine. However, the ability to accurately identify and interpret abnormalities is highly dependent on the training and skill of the individual performing the study.

Veterinarians who perform and interpret diagnostic ultrasound examinations

should be licensed veterinary practitioners having a thorough understanding of the indications and guidelines for ultrasound examinations, as well as familiarity with the basic physical principles and limitations of ultrasound imaging technology. They should be familiar with alternative and complementary imaging and diagnostic procedures and should be capable of correlating the results of these other procedures with the ultrasound examination findings. Veterinarians who perform ultrasound examinations should understand the anatomy, physiology and pathophysiology of the organs or anatomic areas that are being examined. They should be able to acquire ultrasound images that correctly depict anatomy, have a thorough understanding of normal ultrasound anatomy, and must be able to identify abnormal anatomy. These veterinarians should be able to accurately document ultrasound studies and generate a written report on their findings.

The ultrasound training requirements in ACVR approved radiology residencies exceed those of any other specialty organization in veterinary medicine. Radiology residents undertake didactic courses in the physics and technology of ultrasound and learn to correlate ultrasound findings with gross anatomy and surgical pathology. During the 3 to 4 year radiology residency programs, residents must devote a minimum 6 months of intensive clinical training to diagnostic ultrasound, and must conduct a minimum of 1000 ultrasound examinations. Most programs far surpass these minimum requirements. Residents are also required to become proficient at safely performing ultrasound guided fine needle aspirates and biopsies.

The ACVR recognizes that technologists working closely with and mentored by veterinary radiologists can effectively perform ultrasonography, and expand the service provided by radiologists. The ACVR encourages that these technicians perform at least 500 examinations under close supervision by an ACVR Diplomate, have didactic education in veterinary anatomy and ultrasound physics and continued mentorship by an ACVR Diplomate. In the event an ultrasound examination is performed by a technologist without the direct supervision of a radiologist, a written report should be generated and signed by a board certified radiologist based on the radiologist's review of captured diagnostic ultrasound images.

In a survey of the VUS members and the ACVR members ~75% support for this statement.

V. New Business- Create more value in VUS membership.

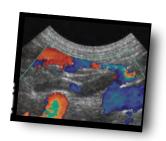
The majority of this meeting focused on member discussion about how to create more value in the VUS membership.

It was decided that VUS should conduct some form of continuing education courses and an online format was agreed upon. This would be either through the VIN or MIRC such

that members only would have access to cases that would be provided by members covering many topics in ultrasound imaging with video clips. This would be a form of education forum driven by the VUS with exclusivity to members, thereby promoting others to become a member. Dr. Blevins agreed to chair a committee and Dennis Keith and Liz Watson, the new members at large, would work with him to submit a proposal to the board.

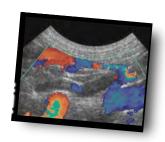

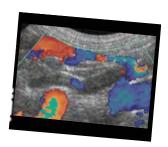

 - Dr. Dominique Pennick spoke on how the ACVR must work with groups that wish to be recognized as ultrasound-experts, like similar experiences in Europe. IVUSS was perhaps not the avenue to do this, but it should be spearheaded by ACVR members in some way.

Dr. Fischetti made the comment that the ACVR should certainly be cautious in not attempting any "certification" efforts for non-radiologists (or non-veterinarians for that matter). In fact, the ACVR is moving away from certification in general (working towards a separate group that would focus on training, testing, and certification: American Board of Veterinary Radiology, ABVR). Members looking to spearhead initiatives for the ACVR to "recognize" but not "certify" organizations that deem themselves ultrasound-experts should contact Dr. Fischetti and/or Dr. Pennick.

Update on VTS progress?

- No members of the veterinary technician specialty in diagnostic imaging were in attendance. No discussion.

Case of the Month Discussion:

- Dr. Fischetti BEGGED a little to get people to contribute COM.

Facebook Policing:

- Dr. Fischetti talked about his role as administrator of the VUS Facebook site, accepting members and firing others that use the site for advertising.
- Dr. Fischetti talked about the lively discussions that take place and promised to share some of these discussions with the list serve over the course of the year.

Current stats

There are 199 society-only members, 306 diplomates, 139 residents and 20 post-trainee members as of 9/12/2018.

Dr. Anthony Fischetti led discussions as outgoing president:

- Introduction to Dr. Adam Watson as the new president.
- 2017 meeting minutes approved.
- The total VUS membership has increased to 664 but there is no plan to increase the VUS dues.
- Facebook case of the month seems well-received and will continue as public rather than for members only.
- The cases will eventually transition to being uploaded on the upcoming new ACVR website with and then be distributed to Facebook 1-3 months later. Dr. Yoskowitz has agreed to be in charge of the Facebook account.
- Goal is to designate at least one member to organize and disseminate our content in social media using multiple platforms (e.g. Facebook, Instagram). Should we pay this person for their duties?
- Call for VUS-sponsored speaker ideas from the membership for the 2019 ACVR meeting.
 Suggestion to send an online survey or email to the membership.

Open Discussion

- Proposal for ACVR VUS endorsement for ultrasound training programs.
- General consensus is that the VUS should be engaged with training companies in the education
 of sonographers to ensure standards are met and increase our involvement as experts in this
 field with the training programs.

- Goal: provide *endorsement* to the training programs that fulfill our published requirements and receive our 'stamp of approval'. We will not be 'certifying' programs.
- How is this achieved? This starts with establishing 'white papers' or consensus statements
 regarding the equipment and technique of performing ultrasound exams on specific body organ
 systems. Image interpretation will NOT be included. If programs fulfill these objects, they will
 be endorsed.
- We need the help of the membership and our ultrasound 'forefathers' to review/author these papers. Dr. Jeryl Jones, VRUS editor, was present and expressed willingness to publish consensus statement as 'other' for VRUS journal.
- Multiple comments and questions came from the audience. An important question arose about
 whether the consensus statements should be applied to all training programs or separated and
 developed for 'weekend training' vs. the longer and more robust programs that last months to
 years (such as technician formal training).

Action items

- The current committee members will begin engaging with the current training programs to review content and with specific diplomates that may be willing to help author the white papers.
- Dr. Watson will email the members regarding interest in working on the white papers.
- Dr. Watson will survey the members on ideas for the 2019 VUS meeting speaker.

Meeting concluded with recognition from the audience for Dr. Fischetti's great work and service as President of VUS for the past two years.
